RESPONSE TO THE NOTICE OF INTENT TO ENTER DEFAULT DECISION AND ORDER
LETTER DATED JUNE 25, 2012

To Whom It May Concern:

My name is Paul Mineer and I am 16 year resident of Loomis, CA. I have 4 kids (2 girls & 2 boys) ages 16, 14, 11, & 8. I have been involved in many different activities within the Loomis Community over the years and continue with my involvement in the community today. I will admit that at times sometimes too involved. This seems to have become one of those times.

Back in late 2005 and into the middle of 2006 I was part of a community group that wanted to help modernize the facilities and provide a safer learning environment for our local K-8 Loomis Union School District (LUSD). This group included parents, teachers, administrators, and others within the community. At that time we sponsored a General Obligation Bond "Measure M – Loomis" on the Nov. 7, 2006 Ballot. Regretfully, we needed 55% of the votes and only obtained 53.04% of 8,505 votes cast. We did not let that squash our hopes of improving the schools. We regrouped and about one year later sponsored another General Obligation Bond "Measure G – Loomis" on the February 5, 2008 Ballot. The results for this measure were very disheartening as we were only able to obtain 52.56% of the 7,892 votes cast.

The total Contributions for Measure M was \$51,609.29 and Expenditures of \$50,289.73 with \$1,419.56 remaining that rolled over to Measure G which had a total of \$26,250 in Contributions and Expenditures of \$28,069.57. [See file "Committee For Measure M and G – Loomis Summary"]

As a whole the Placer County Clerk-Recorder-Elections Office has been very helpful and supportive during the Measure M Election time. I will be the first to admit that I am a novice at the Election/Campaign process. An example when I filed the first two Form 460's I completed the Pre-Election form correctly, but the postelection Semi-Annual report I included the 8/24/2006 to 9/30/2006 amounts a second time on the 8/24/2006 to 12/31/2006 Semi-Annual report. Ferrin Call worked with me to help me so I would not make that mistake again.

Later during the Measure G Election time when the Pre-Election Report was hand delivered on 1/25/2008, the day after the postmark deadline, that I was going to be fined for being 1 day late because it wasn't postmarked on 1/24/2008. I asked that since I was in Auburn and I would be able to hand deliver the filing before they would have received with USPS delivery and I was trying to save on postage but I was informed that is the regulation. So a \$10 fee was paid. This is a little thing in the greater scheme but it caused additional frustrations relating to the process.

Then in July 2008 I thought I was on top of the process. The Semi-Annual Form 460 ending 6/30/2008 was completed on July 30, 2008. Then it was metered the next day at work and was deposited into the USPS Mailbox in Roseville, CA on July 31, 2008. [See file "Measure G - Envelope & 1st Page (20080731)"]. At this point I thought I was doing great until I received a call from Ferrin Call to inform me that her office had not received the Semi-Annual report Form 460. I asked her to check her records because I put it in the mail on the post mark by date so it should have been received. We went back and forth a couple of times and it was never found. This was very frustrating for me because I had tried to do everything

I thought I was supposed to do to avoid any other fees for filing the reports and stay on top of the task to finish out the books for the bond measure. I simply thought that it would be found and there wouldn't be any problems.

Over the last 3-4 years it has been very financially stressing and I have had a number of pressing issues that I had to deal with during this time. In August 2010 we lost our first home due to a number of factors: Bad investments, decline property values, and reduced income to mention a few things. Adding to the family stress was the loss of my Father on July 26, 2011. Needless to say, it has been a very stressful 3-4 years and I am hope the light at the end of the tunnel is not a freight train coming my way.

When Gary from the FPPC Enforcement Division became involved I tried to recreate the information that was apparently lost in the mail but I was not able to locate the files for quite some time so I couldn't recreate the Semi-Annual Form 460 ending 6/30/2008 or the later reports. I looked on a number of occasions in storage, but it wasn't until the end of 2011 that the file was found. It was put mistakenly put in with some project files from work and when they were being reviewed for disposal the file was spotted and returned to me. Then with the file providing me with most of the hard copies of transactions I had to contact the bank to request copies of statements and any missing transactions.

One of the challenges that I faced with being the Treasurer for a small committee supporting a ballot measure is that I really was not aware of what I did not know. It wasn't until March 2012 when I first spoke with Tracy Frazier that I was in a position to be able to dedicate the time and energy into recreating as well as finding the missing transactions with the bank that foreclosed on my home. We spoke about retroactively terminating the committee based on the last day money was expended from the account which was 1/30/2009. Just recently when talking with Tracey Frazier I was made aware of the issue with late contributions and late expenditure requirements for amounts over \$1,000.00 just prior to the election date. I am including a couple of bank statements, copies of check, and a Measure G-Financial Reporting (Cash Flow Register) that was used to track the contributions and expenses.

I remember my grandfather instilling in me a quote by Theodor Roosevelt when I was a boy - *"The first requisite of a good citizen in this republic of ours is that he shall be able and willing to pull his own weight."* I have tried to live by this since then. I have served over 12 years in as a Navy Corpsman in the Reserves being call to active duty on multiple occasions. I am very involved in the community as a Cub Scout Cub Master and Coach for my kids as well as devoting an innumerable amount of time to the creation of the Loomis Basin Education Foundation.

I am very regretful that this situation has been elevated to the point that it is now. I would respectfully request that in light of the mitigation mentioned on page 8 of Exhibit I that there be a lesser penalty levied against a simple citizen trying to do a not so simple task.
