You state:

Section 82015(b)(2)(B)(iii) establishes a third type of payment subject to a unique reporting scheme. This Section provides that even if a payment is made “at the behest” of an elected officer or a member of the Public Utilities Commission (“PUC”),... it is not considered a contribution to that officer if it is made principally for legislative, governmental, or charitable purposes, in which case it is neither a gift nor a contribution. Referred to as “behested payments,” the payment must still be reported, but is not subject to contribution or gift limits. The officer must file a report detailing the payment if the payment is principally for a legislative, governmental or charitable purpose and the aggregate amount is \$5,000 or more.

If the person(s) influenced a contribution by use of his (her) official capacity such as allowing the use of the City Seal in solicitation, would those aggregate contributions not be considered toward any limit, in the definition of the term. The person(s) may be used directly in the solicitation and the City Seal on a page not affiliated with his image or name, but this act places the entire municipality in endorsing fundraising, outside of its Chartered (in the case of a Chartered City) scope. There are no stated duties for fundraising.

What if the person(s) does not run for a City office, but another State or Federal office. What if one or more are running for a City office. You leave this window open and with no time limit in place.

Do all person(s) file who appear on the solicitation file.

We are attaching a sample with two of the three city officials currently running for a City office and the use of the City Seal.

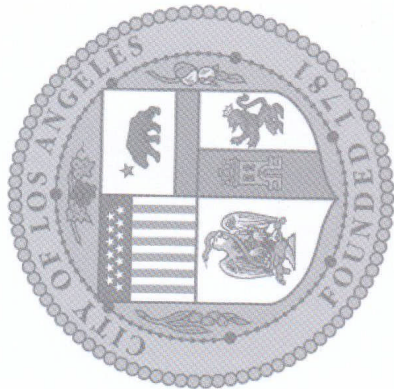

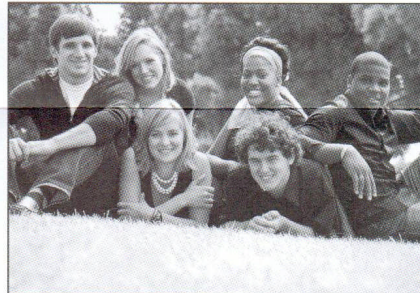
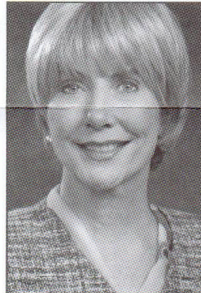
