Chair Miadich and Commissioners of the Fair Political Practices Commission:

I write to you with regard to the Minner Letter discussion (Item 14 on the June 13, 2019 agenda). It is unfortunate that our city presents you with the occasion to examine the scope of the "public generally" exception. While I'm no lawyer, I've taken the time to read and contemplate the "Nerland" advice letter to which the facts in the Minner letter have been compared. I must confess that I don't see how the two sets of facts are in any way comparable.

"Nerland" involved horn noise from trains running through the city of San Pablo, which, as of the 2020 census contained roughly 30,000 people, approximately half the population of Cupertino. The impact at issue in "Nerland" was singular-the sound from horns. The train itself ran from one end of the city to the other. The horn noise could be disruptive for a number of miles in each direction along the entirety of the track running through the city. Accordingly, the advice offered was that the "public generally" exception would apply because a large majority of the residences of San Pablo were located in the corridor where the train ran.

By comparison, the Vallco development at issue in the Minner Letter is located in the far north-eastern end of Cupertino, which is twice the size of San Pablo, and creates many different types of impacts that both the appraisal that the city supplied and common sense would dictate would be felt differently in different parts of the community. Even the appraisal noted the impact of the Vice-Mayor's viewshed, which seems to be unique to her and homes within a similar distance of Vallco.

If as, the Minner Letter states, these two situations are the same, then it seems as though the "public generally" exception would write all meaning out of the rules addressing an official's conflict of interest in the proximity of his or her real property to a project. I wrack my brain to come up with an example where a project could have impacts that reach out beyond 500 feet and yet would not trigger the "public generally" exception. If that's the case, why have these conflict rules at all? Surely, they must have some meaning that the public can understand and apply.

In reviewing some of the letters sent by other members of the public, and I see that a number of the Vice-Mayor's political donors have written in support of the Minner Letter. I've attached just one of many contribution disclosure statements filed on behalf of the Vice-Mayor's election committee. It notes donations from ALL of the Cupertino residents writing in support of the Minner Letter. Others are readily available through the City of Cupertino's digital archives at Cupertino.org. http://Cupertino.org. People going about their daily lives should be able to rest assured that the FPPC relies on facts and law, not political contributions to elected officials. I'm concerned that our local political divisions could result in the creation of a bad precedent that would affect more than just our city.

I ask that you carefully examine the ramifications of letting the Minner Letter stand, and hope that you will revise or rescind it. Our conflict of interest laws should mean something.
