Dear Commissioners,

At the August 20, 2020 FPPC meeting, attorney for the Respondent Lacey Keys Esq. advised the Commissioners that the Foundation had filed Major Donor Form 461 upon notification of the complaint and that it listed the Funds for the Future as the source for the contribution to the Committee.

It is a requirement that nonprofits list the source for the contributions.

The statement by Lacey Keys is not true.

The Responsible Officer who signed the form listed the source on Page 3 is believed to be the COO of the Foundation.

"Contributions made from revenue received in exchange for exclusive distribution or management rights on campus"

As we now know, the funds for the contribution came from an annual **Sponsorship** from Pepsi Bottling and annual multiple **Donations** (one Time and annual) from Barnes and Noble.

Thes contracts were signed by the companies with the District and were a requirement of the contract. The Foundation was not a party to the contracts.

When I placed a public records request with the Foundation for copies of the contracts behind the distribution and management rights referenced, I was told that the Foundation did not have any responsive documents.

Page 8 of the Stipulation states there is no evidence of an intention to conceal, deceive, or mislead the public".

I submit the use of the word "revenue" by the COO was an intentional effort to mislead the public and point direct Enforcement Division away from considering the funds as "donor" funds to avoid being considered as a recipient committee.

The false and misleading statement of the form 461 should be considered as an aggravating circumstance and the penalty should be adjusted upward.

It is clear that the funds used for the contributions were indeed donor funds and the Foundation should be considered a Recipient Committee.
