10 Pursuant to Regulation 18750(f)(2) and this Commission's Order dated
11 February 21, 2014, the Board of Pilot Commissioners for the Bays of San Francisco, San Pablo,
12 and Suisun ("Board") has timely noted its objections to that order and has requested a hearing
13 before the full Commission.

14 The Board's request is granted, as follows:

15 (1) The hearing shall be held during the Commission's regularly scheduled public
16 meeting on July 17, 2014. The Board's argument shall be limited to fifteen minutes. Appellant
17 Pacific Merchant Shipping Association ("PMSA") may appear at this hearing to present
18 responsive argument, not to exceed fifteen minutes.

19 (2) The Board has submitted a written memorandum dated April 22, 2014 in support of
20 its objections. This memorandum was served on the Commission and on counsel for appellant
21 PMSA on April 22, 2014.


22 (3) Appellant PMSA may submit a written memorandum, of the same length and format,
23 in opposition to the objections of the Board. This memorandum may be accompanied by
24 declarations of competent witnesses attesting, under penalty of perjury, to matters of fact
25 supporting the PMSA's position. The memorandum and any declarations must be served on the
26 Commission and on counsel for the Board not later than May 28, 2014.

1 (4) The Board may submit a written memorandum, not exceeding ten pages in length,
2 responding to materials served by PMSA under the preceding paragraph. This memorandum
3 must be served on the Commission and on counsel for PMSA no later than June 11, 2014.


