

1 Amend 2 Cal. Code Regs., Section 18421.4 to read:

2 **§ 18421.4. Reporting Cumulative Amounts for State, City, and County Elections and State,**
3 **City, and County Recipient Committees.**

4 (a) When reporting cumulative amounts of contributions received or made as defined by
5 ~~Government Code section~~ Section 82018 and pursuant to subdivisions (f), (g), (h), and (k) of
6 ~~Government Code section~~ Section 84211, a committee as defined in subdivision (a) of
7 ~~Government Code section~~ Section 82013 controlled by a candidate for elective state office or a
8 candidate for an elective city or county office subject to the contribution limit in Section
9 85301(d) also must disclose the cumulative total(s) of contributions received or made for each
10 election.

11 (b) When reporting cumulative amounts of contributions made as defined by ~~Government~~
12 ~~Code section~~ Section 82018 and pursuant to subdivisions (g) and (k) of ~~Government Code~~
13 ~~section~~ Section 84211, a recipient committee as defined in subdivision (a) of ~~Government Code~~
14 ~~section~~ Section 82013 that makes contributions to candidates for elective state office or to a
15 candidate for an elective city or county office subject to the contribution limit in Section
16 85301(d) also must disclose the cumulative total(s) of contributions made for each election.

17 (c) When filing a campaign statement under ~~Government Code sections~~ Sections 84200,
18 84200.3 or 84200.5, a candidate for elective state office who has accepted the applicable
19 voluntary expenditure limit under ~~Government Code sections~~ Sections 85400-85403 must
20 disclose the cumulative total(s) of expenditures made for each election that are subject to the
21 expenditure limit unless the candidate is no longer subject to the expenditure limit pursuant to
22 ~~Government Code section~~ Section 85402.

23 (d) This regulation does not apply to a candidate for statewide elective office, or the

1 candidate's controlled committee for that office, in an election held before November 6, 2002.
2 This regulation applies on and after November 6, 2002, to a candidate for statewide elective
3 office, and the candidate's controlled committee for that office, in an election held on or after
4 November 6, 2002.

5 (e) This regulation does not apply to a candidate for an elective city or county office, or
6 the candidate's controlled committee for that office, subject to the contribution limit in Section
7 85301(d) prior to January 1, 2021. This regulations applies on and after January 1, 2021, to a
8 candidate for elective city or county office, and that candidate's controlled committee for that
9 office, subject to the contribution limit in Section 85301(d) , in an election held on or after
10 January 1, 2021.
