2 **§ 18545. Contribution Limit and Voluntary Expenditure Ceiling Amounts.**

3 (a) Campaign Contribution Limits

4 (1) For purposes of Section 85301(a), the adjusted contribution limit in effect for
5 candidates for the Senate or Assembly and candidates for elected seats to the Board of
6 Administration of the Public Employees Retirement System or the Teachers' Retirement Board,
7 for an election occurring during the period January 1, 2023 ~~2024~~ through December 31, 2024
8 ~~2022~~ is \$5,500 ~~\$4,900~~ per person.

9 (2) For purposes of Section 85301(b), the adjusted contribution limit in effect for
10 candidates for Lieutenant Governor, Secretary of State, Attorney General, Treasurer, Controller,
11 Superintendent of Public Instruction, Insurance Commissioner and Board of Equalization
12 members for an election occurring during the period January 1, 2023 ~~2024~~ through December 31,
13 2024 ~~2022~~ is \$9,100 ~~\$8,100~~ per person.

14 (3) For purposes of Section 85301(c), the adjusted contribution limit in effect for
15 candidates for Governor for an election occurring during the period January 1, 2023 ~~2024~~
16 through December 31, 2024 ~~2022~~ is \$36,400 ~~\$32,400~~ per person.

17 (4) For purposes of Section 85302(a), the adjusted contribution limit in effect for
18 candidates for Senate or Assembly and candidates for elected seats to the Board of
19 Administration of the Public Employees Retirement System or the Teachers' Retirement Board,
20 for an election occurring during the January 1, 2023 ~~2024~~ through December 31, 2024 ~~2022~~ is
21 \$10,900 ~~\$9,700~~ per small contributor committee.

22 (5) For purposes of Section 85302(b), the adjusted contribution limit in effect for
23 candidates for Lieutenant Governor, Secretary of State, Attorney General, Treasurer, Controller,
24 Superintendent of Public Instruction, Insurance Commissioner and Board of Equalization

1 members for an election occurring during the period January 1, ~~2023~~ ~~2021~~ through December 31,
2 ~~2024~~ ~~2022~~ is \$18,200 ~~\$16,200~~ per small contributor committee.

3 (6) For purposes of Section 85302(c), the adjusted contribution limit in effect for
4 candidates for Governor for an election occurring during the period January 1, ~~2023~~ ~~2021~~
5 through December 31, ~~2024~~ ~~2022~~ is \$36,400 ~~\$32,400~~ per small contributor committee.

6 (7) For purposes of Section 85303(a), the adjusted annual contribution limit to any
7 committee, other than a political party committee, in effect for an election occurring during the
8 period January 1, ~~2023~~ ~~2021~~ through December 31, ~~2024~~ ~~2022~~ is \$9,100 ~~\$8,100~~ per person.

9 (8) For purposes of Section 85303(b), the adjusted annual contribution limit to any
10 political party committee in effect for an election occurring during the period January 1, ~~2023~~
11 ~~2021~~ through December 31, ~~2024~~ ~~2022~~ is \$45,500 ~~\$40,500~~ per person.

12 (9) For purposes of Section 85301(d), the adjusted contribution limit in effect for
13 candidates for elective city or county office for an election occurring during the period of
14 January 1, ~~2023~~ ~~2021~~ through December 31, ~~2024~~ ~~2022~~ is \$5,500 ~~\$4,900~~ per person.

15 (b) Voluntary Expenditure Ceilings

16 (1) For purposes of Section 85400(a)(1), the adjusted voluntary expenditure ceiling in
17 effect for Assembly candidates for an election occurring during the period January 1, ~~2023~~ ~~2021~~
18 through December 31, ~~2024~~ ~~2022~~ is \$727,000 ~~\$649,000~~ in the primary or special primary election
19 and \$1,273,000 ~~\$1,135,000~~ in the general or special general election.

20 (2) For purposes of Section 85400(a)(2), the adjusted voluntary expenditure ceiling in
21 effect for Senate candidates for an election occurring during the period January 1, ~~2023~~ ~~2021~~
22 through December 31, ~~2024~~ ~~2022~~ is \$1,091,000 ~~\$973,000~~ in the primary or special primary
23 election and \$1,636,000 ~~\$1,459,000~~ in the general or special general election.

1 (3) For purposes of Section 85400(a)(3), the adjusted voluntary expenditure ceiling in
2 effect for State Board of Equalization candidates for an election occurring during the period
3 January 1, 2023 ~~2021~~ through December 31, 2024 ~~2022~~ is \$1,818,000 ~~\$1,621,000~~ in the primary
4 election and \$2,727,000 ~~\$2,432,000~~ in the general election.

5 (4) For purposes of Section 85400(a)(4), the adjusted voluntary expenditure ceiling in
6 effect for a candidate for Lieutenant Governor, Secretary of State, Attorney General, Treasurer,
7 Controller, Superintendent of Public Instruction, and Insurance Commissioner for an election
8 occurring during the period January 1, 2023 ~~2021~~ through December 31, 2024 ~~2022~~ is
9 \$7,272,000 ~~\$6,485,000~~ in the primary election and \$10,908,000 ~~\$9,728,000~~ in the general
10 election.

11 (5) For purposes of Section 85400(a)(5), the adjusted voluntary expenditure ceiling in
12 effect for a candidate for Governor for an election occurring during the period January 1, 2023
13 ~~2021~~ through December 31, 2024 ~~2022~~ is \$10,908,000 ~~\$9,728,000~~ in the primary election and
14 \$18,181,000 ~~\$16,212,000~~ in the general election.

15 (c) Officeholder Contribution Limits (per contributor per calendar year)

16 (1) For purposes of Section 85316, the adjusted contribution limit in effect for
17 officeholders in the Senate or Assembly for calendar year 2023 ~~2021~~ and 2024 ~~2022~~ is \$4,500
18 ~~\$4,000~~ per person per calendar year.

19 (2) For purposes of Section 85316, the adjusted contribution limit in effect for
20 officeholders in statewide elected state offices (other than Governor) for calendar year 2023
21 ~~2021~~ and 2024 ~~2022~~ is \$7,500 ~~\$6,700~~ per person per calendar year.

1 (3) For purposes of Section 85316, the adjusted contribution limit in effect for the
2 officeholder in the Governor's office for calendar year 2023 ~~2021~~ and 2024 ~~2022~~ is \$30,200
3 ~~\$26,900~~ per person per calendar year.

4 (d) Officeholder Contribution Limits (aggregate)

5 (1) For purposes of Section 85316, the adjusted aggregate officeholder contribution limit
6 in effect for officeholders in the Senate or Assembly for calendar years 2023 ~~2021~~ and 2024
7 ~~2022~~ is \$75,500 ~~\$67,300~~ per calendar year.

8 (2) For purposes of Section 85316, the adjusted aggregate officeholder contribution limit
9 in effect for officeholders in statewide elected state offices (other than Governor) for calendar
10 years 2023 ~~2021~~ and 2024 ~~2022~~ is \$151,000 ~~\$134,600~~ per calendar year.

11 (3) For purposes of Section 85316, the adjusted aggregate officeholder contribution limit
12 in effect for the officeholder in the Governor's office for calendar years 2023 ~~2021~~ and 2024
13 ~~2022~~ is \$301,900 ~~\$269,300~~ per calendar year.

14 (e) The contribution limit and the voluntary expenditure ceiling adjustments shall be
15 made pursuant to Regulation 18544.

16 (f) The contribution limit and voluntary expenditure ceiling adjustments of this regulation
17 also will apply to elections held after December 31, 2023 ~~2022~~, until these limits are adjusted by
18 the Commission for the next biennial period.
