

1 Amend 2 Cal. Code Regs., Section 18410 to read:

2 **§ 18410. Statement of Organization.**

3 (a) The Secretary of State shall reject the filing of a Statement of Organization unless it
4 contains all of the following information:

5 (1) Indication of the “Statement Type,” whether initial, amendment, or termination and,
6 if the committee has qualified, the date of qualification or, if the statement is a termination
7 statement, the date the committee terminated.

8 (2) The committee identification number, if the filing is an amended statement.

9 (3) The full name, as required by the Act and Commission regulations, street address,
10 email address, and telephone number of the committee.

11 (4) The full name, street address, and telephone number of the treasurer.

12 (5) Indication of the type of committee by completing at least one of the following
13 sections: controlled committee; primarily formed committee; or general purpose committee.

14 (6) If the committee is a candidate controlled committee, the full name and office sought
15 by a candidate, including district number, if applicable.

16 (7) If the committee has qualified, the name and address of the financial institution where
17 the campaign bank account is located, the names of persons, other than the treasurer, who are
18 authorized to obtain the bank records of the committee from the financial institution where the
19 campaign bank account is maintained, and the account number. If there are more than two
20 persons other than the treasurer authorized to obtain the bank records, the committee need only
21 list two persons. For committees existing prior to January 1, 2023, the Statement of Organization
22 shall be amended to include the names of those authorized to obtain the bank records by July 1,

1 2023, or the next time the committee files an amended Statement of Organization, whichever is
2 earlier.

3 (8) If the committee is a noncandidate controlled committee, the name of each principal
4 officer as set forth in Section 84102(c) and Regulation 18402.1.

5 (9) If the committee is a committee primarily formed to support or oppose specific
6 candidates or measures in a single election, the name of the candidate or the number, letter, or
7 full title of the ballot measure, the jurisdiction, and whether the committee is formed to support
8 or oppose the candidate or measure.

9 (10) If the committee is a general purpose committee, indication of whether the
10 committee is a city, county, or state committee and a brief description of its activity.

11 (11) If the committee is a sponsored committee, the full name, street address, and
12 telephone number of each sponsor and the industry group or affiliation of each sponsor as
13 required in Regulation 18419(b)(2).

14 (12) If the committee (A) submits a proposed state ballot measure to the Attorney
15 General's Office for title and summary, (B) spends \$100,000 or more on circulation of petitions
16 for a proposed state ballot measure, or (C) is primarily formed to support or oppose a proposed
17 state ballot measure that has been submitted to the Attorney General for title and summary, the
18 committee shall state the identification number assigned by the Attorney General's Office to the
19 proposed ballot measure and the title of the proposal on the statement of organization. The
20 Attorney General's identification number and the title of a proposed measure shall no longer be
21 required on a committee's statement of organization after any of the following: the measure has
22 failed to qualify for the ballot, the measure number has been added to the committee's name, or
23 the election in which a measure qualified for the ballot has been held.

1 (13) Signed verification of the statement, including the date, by the treasurer or
2 assistant treasurer and controlling officeholder, candidate, or state measure proponent.

3 (b) A committee is not in compliance with the provisions of Section 84101 or 84103 until
4 such time as the Secretary of State accepts for filing a statement of organization or amendment
5 thereto that provides the information required under subdivision (a)(1-13).

6 (c) Notwithstanding the above provisions, if the statement of organization filed is an
7 amendment or termination and the information contained on the previous statements of
8 organization filed by the committee is correct, the amended statement need only include the
9 committee name, identification number, and verification along with the amendment, if an
10 amended statement, or the termination date, if a termination statement.
