**A. Call to Order**

Chair Miadich called the meeting to order at 10:07 a.m.

**B. Public Comment for Items not on the Agenda**

Scott Vaughan gave public comment to discuss his believed facts regarding a complaint submitted to the Enforcement Division. Chair Miadich thanked Mr. Vaughan for bringing the underlying matter to the attention of the FPPC, and stated that the Commission would be reviewing its regulations for possible amendment.

**C. Approval of Minutes of Prior Meeting**

**MOTION:** Approve the October 18, 2019 meeting minutes. Moved by Commissioner Hayward, seconded by Commissioner Cardenas. Motion approved 4-0.

**D. Approval of Enforcement Consent Calendar.**

**MOTION:** Motion to approve the Enforcement Consent Calendar, agenda items 3-15. Moved by Commissioner Hayward, seconded by Commissioner Cardenas. Motion approved 4-0.

Multiple members of Contra Costa County gave public comment on agenda item 3, *In the Matter of Joe Canciamilla for Contra Costa County Clerk/Recorder 2014/2018, Friends of Joe Canciamilla for Judge 2012/2014, and Joseph Canciamilla*, to ask the Commission to reject the stipulation and seek a larger fine. Following public comment, and assurance from the Enforcement Division that a criminal referral had been made, the Commission approved the proposed stipulation, and requested that the Enforcement Division refer the matter to the Contra Costa County Employees' Retirement Association for any action the Association deemed appropriate.

**E. Adoption of the 2019/2020 Statement of Economic Interests, Form 700 and related documents.**

**MOTION:** Motion to approve the 2019/2020 Statement of Economic Interests forms. Moved by Commissioner Hatch, seconded by Commissioner Hayward. Approved 4-0.

**F. Updated Campaign Manuals and Lobbying Manual.**

**MOTION:** Motion to approve the updated campaign manuals and lobbying manual. Moved by Commissioner Hatch, seconded by Commissioner Hayward. Approved 4-0.

Amendments to Regulation 18450.1, Advertisement Disclosure and Regulation 18435, Definitions of Mass Mailing and Adoption of Regulation 18450.2, Authorized and Paid For, Regulation 18450.3, Top Contributor Disclosure for Affiliated Entities, and Regulation 18450.4, Video and Television Advertisement Disclosure.**

**MOTION:** Motion to approve the proposed regulations with discussed amendments. Moved by Commissioner Hatch, seconded by Commissioner Hayward. Approved 4-0.

**H. Update on Task Force to Study Best Practices for Regulating Campaign Activity on Digital Media**

**I. Memo regarding gift rules and college scholarships.**

**MOTION:** Motion to instruct Staff to create a fact sheet on scholarships. Moved by Chair Miadich, seconded by Commissioner Hayward. Approved 4-0.

**J. Approval of Commissioner Compensation Request.**

**MOTION:** Motion to approve the July compensation request submitted by Commissioner Hatch. Moved by Chair Miadich, seconded by Commissioner Hayward. Approved 4-0.

**K. Committee Updates.**

Commissioner Hayward stated the Budget & Personnel Committee update is as submitted.

**L. Advice Letter Report and Commission Review.**

**MOTION:** Motion to withdraw advice letter A-19-169. Moved by Commissioner Hatch, seconded by Commissioner Cardenas. Motion failed 2-2, with Chair Miadich and Commissioner Hayward opposing.
