Subject: Comment Letter Regarding 87200 Filers filing directly through the FPPC Filing system

I understand that in accordance to recent changes resulting from AB 1170, effective January 1, 2025 all 87200 filers will be required to file electronically directly with the FPPC using your filing system. I write to express my concern with this change and the confusion and extra work it will cause for the filers. We have for several years had an approved electronic filing system in place for all filers. This system automatically transmits all 87200 filers filings directly to the FPPC. Requiring that 87200 filers file directly with the FPPC using their system, will require the filers to have to file duplicate filings in different systems. I ask that you consider our request to continue to allow filers from agencies that have electronic filing systems in place to file through their agencies system and have it transmitted to the FPPC system.
